#### **OUR PRESIDENT**

Since the inception of 21 & Change, Inc., our organization has served and positively impacted 105 families spanning 19 counties throughout the State of Florida. In 2023 alone we helped 39 families get the correct support they needed in public schools, as well as expanded our reach by integrating a new Water Safety Program in Tampa Bay for children with developmental disabilities. These families, much like ourselves, consist of your neighbors and friends who require assistance from 21 & Change to guarantee that their children receive a fair and advantageous education. Without the backing of our community, donors, elected representatives, and you, we would be unable to cater to a group that is frequently neglected in Florida. Your ongoing commitment to our organization has played a vital role in our mission to support families with children with developmental disabilities. I am thrilled to share with you the incredible impact that your contributions have had on the families we serve.

In June, we hosted our 5th Annual Champions for Change with Teco as our Champion Sponsor. We had the biggest participation level yet at this event with 42 participants; 21 of which were children with developmental disabilities.

In August, we began offering water safety lessons as a part of our community outreach program. We donated a total of \$5600 to families that could not afford to enter their child into water safety lessons in hopes of reducing drowning of children with developmental disabilities.

In September of 2023, our organization also experienced another leadership change as our President Clayton Clemens accepted a new career role and stepped down from the board and officer service. The board of directors, advisory council, IEP Advocates, sponsors, partners, scholarship recipients and their families, volunteers, and all those who have supported our organization and its mission are thankful to Clayton for his determination, enthusiasm, and hard work in maintaining such a remarkable organization that challenges the norm and aids those in need. With a clear understanding of the ongoing necessity for our organization's services in our state, I was nominated and unanimously approved by the Board of Directors to assume the role of President of 21 & Change. As we embark on this new chapter, I anticipate adding new board members and advisors to diversify our dedicated and motivated Board of Directors further, and I aim to build our network and refine our programs to allow us to assist even more families. As we progress, I hope that you will continue to support our mission of advocating for inclusion, education, and human rights for individuals with developmental disabilities.





Over the past year, 21 and Change has made significant progress in supporting children with developmental disabilities. We have provided direct assistance to numerous families by advocating for them in Individualized Education Program (IEP) meetings, offering evaluations, assessments, and essential services. While our direct support capacity is limited, our strategic partnerships have played a crucial role in expanding our impact exponentially. Collaboration has always been a fundamental principle guiding our achievements. Our exceptional IEP Advocacy Scholarship program exemplifies this philosophy, empowering deserving students to access education and necessary

accommodations. Through close collaboration with educational institutions, service providers, and organizations, we have established a strong support network. Our commitment remains steadfast to our mission of ensuring equal opportunities for these exceptional individuals. Together, we can construct an inclusive society where every child with a developmental disability can thrive.

In 2023, we are honored to highlight the efforts of Debra Mitchell, a selfless advocate for children with developmental disabilities in Florida's schools. During this legislative session, we remained deeply engaged in our mission to uplift the voices of children with developmental disabilities and their families, working hand in hand with our partners in Tallahassee.

Notably, we expanded our reach by instilling our new Water Safety Program to improve the well being of the developmentally disabled children of the Tampa Bay area. In 2022, Florida had the highest child drowning rate in the U.S. with a number as high as 94. Our organization donated over \$5600 to this effort and, in turn, did our part to contribute to decreasing the number of drownings in Florida in the future. This milestone signifies a remarkable step forward in safeguarding the wellbeing of our children.

## OUR NUMBER 1PROGRAM.

In 2023, we granted 39 scholarships totalling an impressive \$29,500. It is important that we take the time to understand the real work that is being done behind the scenes. One of our cherished Advocates Debra Mitchell deserves to be recognized.

Debra Mitchell has been in Special Education for over 20 years at both the school, district, advocate and consulting level. She has tracked over 5000 meetings in her 20 years in the profession. Since establishing her business in 2022 as an Advocate and Educational Consultant, she has helped over 250 parents that have had need for advocacy.



#### A word from Debra:

"Prior to being an educator, I was a Retirement Relationship Manager for a fortune 500 company. I understand the financial impact of having a child with a disability. I heard the call to become a civil servant in education and accepted the challenge. I pride myself in bringing a wealth of knowledge and expertise to the table. I have been on both sides of the table as a parent of a student with a disability, teacher, charter school administrator, Pre k – Administrator, school level administrator, district level administrator, and regional administrator in the seventh largest School District in the United States. I am grateful for the knowledge and skills that I have learned and developed and I want to give back. I seek to consult with parents to address their concerns and advocate for their child while working with their child's school district.

In 2023 a family contacted me to assist with their Autistic child who had been placed in an educational setting that limited him academically and socially. Unfortunately, the parent was unemployed and struggling to make ends meet. As a new business I wanted to help but also have to maintain and pay my company expenses. I worked with the parent to develop in IEP that was individualized to her child. It took lots of coaching with the parent and advocating on the child's behalf. I have checked in with the family each semester. I am happy to say the student is doing well."
